

# WARRANTY

**RAFTER M TRAILERS INC.** protection warrants to the original owner that every **TRAVALONG** steel trailer will be free from defects in materials or workmanship for a period of 5 years. If the trailer is rented or leased for commercial hauling the warranty is null and void.

**ACTIVATION** warranty card must be completed and returned to Rafter M Trailers Inc. within 30 days from the date of purchase to activate warranty coverage.

**EXCLUSIONS** Components incorporated but not manufactured by Rafter M Trailers Inc. including but not limited to tires, axles, brake components, springs and other suspension components, couplers, jacks, tarps, mats, batteries, windows and doors, are warranted by their manufacturer. A copy of their policy is available upon request.

Transportation of any trailers to and or from the dealer, the factory or any other approved repair facility is the responsibility of the trailer owner. Rafter M Trailers Inc. shall not be liable for any such costs or physical transportation.

Warranty does not cover paint defects caused by "normal use" and deterioration due to exposure such as chipping, scratching, fading, cracks in caulk seams, road salt or tar, damage by animals or pressure washing.

**WATER LEAKS** Rafter M Trailers Inc. makes a concerted effort to provide a waterproof product but does not guarantee or warrant against water leakage.

**TRANSLUCENT ROOF MATERIAL** is warranted to be free from defects in material and workmanship for a period of 5 years. The material is warranted not to crack, break, shatter or decompose under normal working conditions. Damage caused by wind, tornado, hurricane, floods and other acts of God are not covered.

**MIS-USE AND ABUSE** such as loading in excess of gross vehicle weight rating will void warranty.

**PRIOR CONSENT** from Rafter M Trailers Inc. is required to qualify for replacement or reimbursement to any dealer or trailer owner for repairs. In order to qualify Rafter M Trailers Inc. may require pictures or at its discretion may require that the parts be shipped to the original manufacturer, or returned to Rafter M Trailers Inc. for inspection. The exclusive remedy under this warranty will be a Rafter M Trailers Inc option to repair, or replace any product which Rafter M Trailers Inc determines to be defective within the scope of this policy. Authorized repairs or replacements do not extend the term of this limited warranty.

**LIMITATIONS** The sole responsibility of Rafter M Trailers Inc. under this limited warranty shall be to repair or replace defective parts at a Rafter M Trailers Inc. facility, or with written pre-approval at another location for a reimbursement not exceeding the price Rafter M Trailers Inc. would charge for the service or parts. All other obligations or liabilities, including incidental or consequential damages or contingent liabilities arising out of the failure of any components are hereby excluded, including but not limited to any damages resulting from loss of use, inconvenience, loss of time, commercial loss or any other type of damages, general or specific, foreseen or unforeseen, unless applicable state or federal law provides otherwise. Rafter M Trailers Inc. reserves the right to make additions, deletions and or improvements without being obligated to install or modify same upon previously manufactured products.

This warranty is in lieu of any and all other warranties expressed or implied including merchantability and fitness and no one is authorized to make any further or additional warranties on behalf of Rafter M Trailers Inc.
